

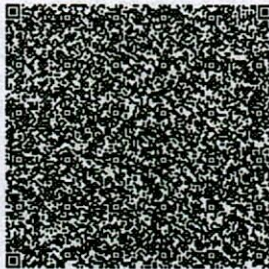

M/s. Pondicherry Solidwaste Management Company Private Limited, Rajeev Gandhi Land Mark, Thuthipet, Villiyanur Commune, Puducherry-605 502, here in after, referred as **PSMPL** represented by Mr.N.Vasantharajan, Plant Manager.

And

M/s. Sri Manakula Vinayagar Medical College and Hospital, Kalitheerthalkuppam, Puducherry – 605 107, represented by Mr.M.Dhanasekaran, Chairman and Managing Director.

PSMPL, as the approved Common Bio Medical Solidwaste Management Facility by Puducherry Pollution Control Committee, has been contracted by **SMVMC&H** for Collection, Treatment and Disposal of the segregated Bio Medical Solid waste in RED and YELLOW color coded bags and other solid wastes.

Whereas, **SMVMC&H** as statutory requirement, need to manage their Solid waste in adherence to **Bio-Medical Wastes (Management and Handling) Rules, 2016**.

Whereas **SMVMC&H**, agrees to utilize the services of **PSMPL** in the scope of the following Terms and Conditions of the agreement:

1. **PSMPL** will collect the Bio Medical Wastes, in color-coded bags, provide tied and in leak proof condition as per BMW Rules, 2016.
2. **PSMPL** agrees to provide the services to **SMVMC&H**, to be complied with the BMW, Rules, 2016 on a 'user-pay-principle' at Rs. 8.25/= per bed per day for 700 beds; but assessed only for 80% occupancy and that the net bed account for the purpose of service cost will be 560 beds only. Hence, the net amount payable is Rs.1,38,600/= However, in view of other service contracts like supply of color coded bags (Rs.66,337/-), manpower (Rs.35,000/-) and collection of non medical waste within the hospital premises of **SMVMC&H**, **PSMPL** is agreed to extend the entire service contract for a lump sum price of Rs.2,39,937/- per month. This is to be paid on monthly basis plus taxes/duties if applicable.
3. **PSMPL** is bound to disclose all details about this agreement and services to PPCC, as and when it is required.
4. **PSMPL** will enable **SMVMC&H** to get authorization from PPCC, for necessary structures for collection and segregation of Bio-Medical Wastes.
5. **PSMPL** shall not demand or utilize any of the manpower who are on regular or contract employment with **SMVMC&H**.
6. **PSMPL** shall collect the wastes from **SMVMC&H** daily (within 24 hours of time) from mutually agreed location and time.
7. In case, if **PSMPL** fails to collect the waste within 24 hours of previous collection time, the same shall be cleared within the next 24 hours. If for some reason, **PSMPL** has not cleared the BMW within 48 hours that day's 50% charges will be reduced in the billing.
8. **PSMPL** shall be responsible for any violation under the **Bio-Medical Waste Management Rules (amended), 2018** from the time, the waste is collected at the premises of **SMVMC&H** and shall comply with all the rules and regulations stipulated by the PPCC.
9. In case **SMVMC&H** find any irregularities in the collection of waste they can send a notice in writing to **PSMPL** for immediate action. All complaints (if any) shall be attended to in the shortest possible time (48 hours)
10. **PSMPL** shall raise the INVOICE for payment on monthly basis on or before 2nd of every month. **SMVMC&H** is expected to make the payment by DD/Account Pay Cheque/only drawn in favour of Pondicherry Solidwaste Management Company Private Limited payable at Puducherry. DD/Cheque on or before 10th of every month.

11. If the payment against the invoice submitted is delayed beyond 21 working days from the date of submission, an interest of @ 6% may be paid to the service provider, **PSMPL** by **SMVMC&H**.

13. As per **Bio Medical Waste Management Rules (amended), 2018** barcode enabled color coded plastic bags must be used for collection and transport of BMW. On implementation of the use of bar coded plastic bags for BMW collection, **PSMPL** will stop supply of BMW collection plastic bags to **SMVMC&H** with one week's notice. A separate invoice and agreement shall be deemed for supply of bar code enable color coded plastic bags for BMW collection & transport and bar code management software.
14. Agreement can be terminated by giving one-month notice from either side with intimation to **PPCC**.
15. This "Agreement of Service" shall be valid up to **31st July 2019** and with due clause for renewable by mutual consent for the future periods.

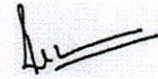

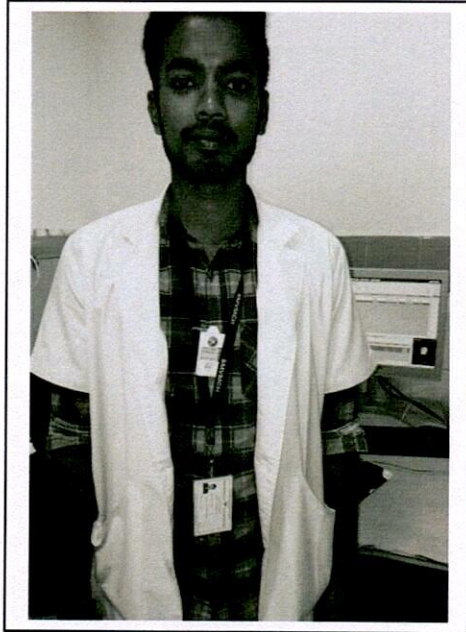
