



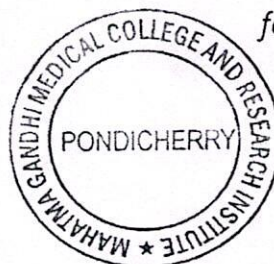

### **3. Probation:**
