Sub. Continuance of recognition of MBBS degree granted by Pondicherry University, Pondicherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry.

Sir/ Madam,

I am directed to inform that the assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Pondicherry University, Pondicherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry was carried out by the Council Assessors on 9th and 10th May, 2016. The assessment report (9th and 10th May, 2016) was considered by the Executive Committee at its meeting held on 13.05.2016. The following recommendations of the Executive Committee was approved by the General Body of the Council at its meeting held on 22nd November, 2016:-

"The Executive Committee of the Council considered the assessment report (9th and 10th May, 2016) and decided to recommend that recognition of MBBS degree granted by Pondicherry University, Pondicherry in respect of students being trained at Sri Manakula Vinayagar Medical College & Hospital, Pondicherry be continued restricting the number of admission to 150 (One Hundred fifty) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the General Body has been approved by the Oversight Committee on 28.04.2017.





3. The admission process for the academic year 2006-07 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulations, 1997, as amended.



Sir,

I am directed to refer to your proposal on the subject mentioned above, seeking permission of the Central Govt. to start a new medical college in the name and style of "Sri Manakula Vinayaga Medical College & Hospital" at Kalitheerthalkuppam, Pondicherry by Sri Manakula Vinayaga Educational Trust, Pondicherry under Section 10 (A) of the Indian Medical Council Act, 1956, as amended and to say that your proposal was referred to the Medical Council of India for its evaluation and recommendation.

2. After careful consideration of the scheme and taking into consideration the recommendations of Medical Council of India in this regard, this Ministry have come to a conclusion that the letter of intent for establishment of a new medical college at Kalitheerthalkuppam, Pondicherry by Sri Manakula Vinayaga Educational Trust, Pondicherry with an annual intake of 150 (One Hundred fifty) students with prospective effect under Section 10 (A) of IMC Act may be issued.

Hence this letter of Intent.

3 This letter of intent is subject to the fulfillment of the following conditions:-

- (i) The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipments and hospital facilities as per Medical Council of India norms.

- (ii) Other deficiencies pointed out in the inspection report should be rectified. A copy of inspection report is enclosed.
- (iii) No student should be admitted in the above college till the formal permission of Central Govt. is granted.
- (iv) The applicant should provide a Bank Guarantee of Rs.9.50 Crores (Rupees 2.00 Crores towards medical college and 7.50 crores towards hospital facilities) valid for five years from a nationalized/ scheduled Bank as per the norms of the Medical Council of India.
4. Action to grant formal permission of the Central Govt. for starting of a new medical college at Kalitheerthalkuppam, Pondicherry by your Trust will be initiated on receipt of a compliance letter fulfilling the conditions enumerated in the paragraph 3 above.

It is to inform that the Medical Assessment Rating Board (MARB) of National Medical Commission (NMC) considered the Assessor's report (23/02/2021) together with the recommendations of the PG Expert Group on the physical and other teaching facilities available at Sri Manakula Vinayagar Medical College and Hospital, Puducherry under Pondicherry University, Puducherry for Increase of seats in MS(General Surgery) course u/s 10(A) of the IMC Act, 1956 and section 61(2) of the NMC Act, 2019 for the academic year 2021-2022 and decided as under:

"The Medical Assessment and Rating Board (MARB) considered the Assessor's Report 23/02/2021 together with recommendations of the PG Expert Group and decided to issue Letter of Permission for Increase of seats in MS(General Surgery) course at Sri Manakula Vinayagar Medical College and Hospital, Puducherry under Pondicherry University, Puducherry u/s 10(A) of the IMC Act, 1956 and section 61(2) of the NMC Act, 2019 prospectively i.e. from the academic session 2021-22 for 05 to 09 (Seats) per year till the first batch admitted against the approved number, appears in the final examination of the said course. It shall be incumbent upon the Medical College that the information relating to admission should be submitted within the time specified in the circular in this regards issued by this office from time to time. Any failure to submit the information within this time limit would be construed that the admission in the College were not in accordance with the statutory requirements, thereby enabling the Commission to proceed in accordance with law against the college.

Action to grant formal permission of the Medical Assessment and Rating Board (MARB) for increased intake/starting of the said course at your college will be initiated on receipt of appropriate bank guarantee, if applicable and undertaking/ compliance letter fulfilling the conditions enumerated above. The acceptance letter may be sent within 2 (two) weeks from the date of issue of this letter to enable the Medical Assessment and Rating Board (MARB) to issue Letter of Permission for the academic year 2021-22.
