The following are the areas that will benefit immensely by e-governance.

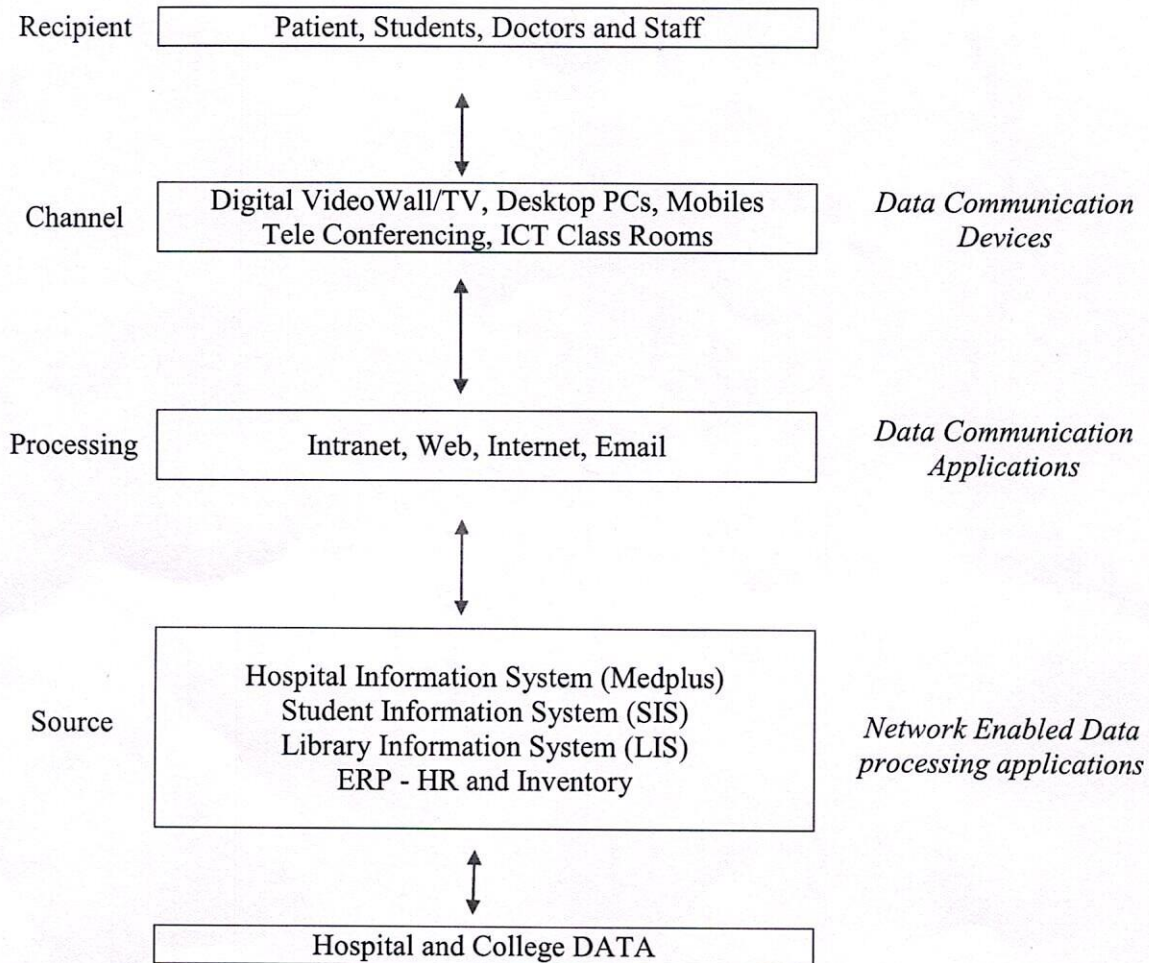

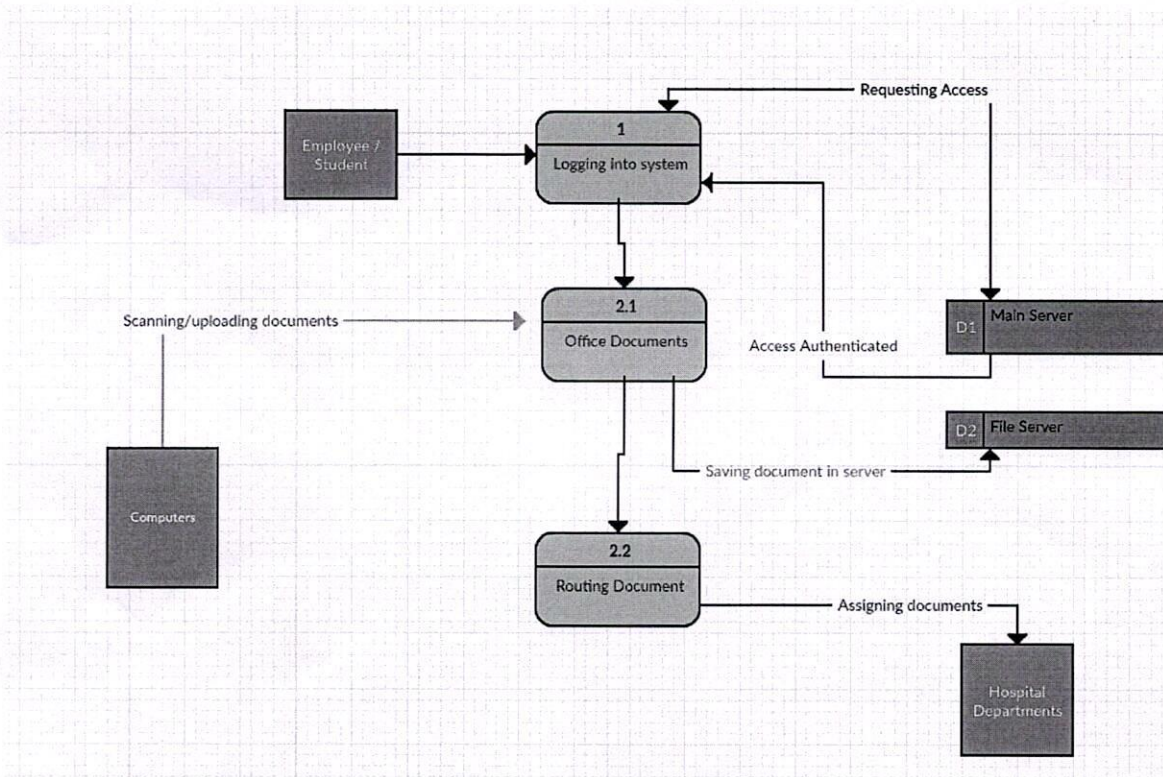

For these reasons, healthcare and student records are surrounded by security measures. Ensuring the confidentiality of information while in transit from one practitioner to the next, and while being stored, is imperative to avoid eavesdropping by unauthorized individuals.
